Participation in SLC and State CDEs are required. The FFA Chapter participates in a national FFA activity once every two years.

The FFA Chapter participates in: 6 separate district events that include a balance of participation in leadership and content specific CDEs. 4 separate state events that include a balance of participation in leadership and content specific CDEs that are included on the FFA district and Idaho FFA Association calendar.
