Robert Hale moved the Floriculture CDE Plant Identification and Equipment Scorecards include a place for students to put their name, chapter, etc, make the answer spots less wide, and vertically list the equipment identification answer boxes. Cody Park seconded. Motion passed.

Janna Volkers moved to accept the overall formatting changes to Floriculture CDE paperwork suggested by the Floriculture CDE Superintendent. Larin Crossley seconded. Motion passed.

Cody Porath moved that flat iron steak wording be removed from the identification list of the Meats CDE. Robert Hale seconded. Motion passed.

Robert Hale moved that events will be available for verification following completion of scoring in all events for which scores determine rank. Individual scores for each section of the event, along with team scores where appropriate will be placed in folders and will be accessible only to the advisor of the chapter. Folders will be available at a central location during CDEs and monitored by a CDE volunteer or staff member. Teachers will be allowed to view scores only. If there is a discrepancy then the teacher must talk to the scoring coordinator and/or the superintendent and then refer back to the supporting materials after these steps. Mark Beitia seconded.
